

Booba One — Purchase Process

Valid from summer 2026 · Urbanoid GmbH, Kaiserslautern

This document sets out the binding ordering procedure for the Booba One following a personal consultation (telephone call) with one of the founders. It is intended for prospective buyers who wish to place a reservation.

1. The Product

The Booba One is available as a standalone model. Individual colour requests and special paint finishes will be discussed during the consultation and set out in writing in the preliminary contract.

2. Order process following the telephone call

The following procedure applies to all prospective buyers who wish to make a reservation following a face-to-face meeting with Martin Paul Hoffmann or Thomas S. Offenbeck.

- 1 Receiving and checking the preliminary contract**
Following the phone call, you will receive the preliminary contract by email as a PDF. Please check all the details carefully: model, colour, price, delivery date and your personal details. If anything is unclear, please contact us directly.
- 2 Preliminary contract signed and returned**
Print out the preliminary contract, sign it and send a scanned copy or a photograph of it to hello@urbanoid.eu. A simple mobile phone photo will suffice. We will confirm receipt within 48 hours.
- 3 Please transfer a booking deposit of €500**
Please transfer €500 to our account (bank details are in the preliminary contract). Please state your name and 'Booba One Reservation' as the payment reference. The deposit will be credited in full towards the purchase price.
- 4 Order confirmation received**
As soon as we have received the signed preliminary contract and your deposit, you will receive a written order confirmation stating your delivery date. You are now officially part of the first series.
- 5 Final payment and collection / delivery**
The remaining €15,400.00 is due no later than 14 days before the agreed delivery date. Delivery will take place from our factory in Großbreitenbach (Thuringia) or as otherwise agreed.

3. Delivery and handover

Handover takes place in person. At our Monday site in Großbreitenbach (Thuringia), you can set up your Booba Pro and test all its functions before collection. A brief induction is, of course, included.

Delivery to another location is possible on request and subject to a separate agreement. The applicable transport costs will be set out individually in the preliminary contract.

4. Right of withdrawal and cancellation

The statutory right of withdrawal under Sections 355 et seq. of the German Civil Code (BGB) remains unaffected. The withdrawal period is 14 days from the date the contract is concluded. A separate notice of withdrawal forms part of the preliminary contract.

We recommend that you contact us if you have any questions before signing — we will make time for you. Withdrawal after the withdrawal period has expired is only possible in exceptional cases and subject to a written agreement. In such cases, the deposit of €500 is generally non-refundable, unless Urbanoid GmbH is unable to meet the agreed delivery date.
